PREAMBLE :-

Rajas Dental College & Hospital, Kavalkinaru Junction, Tirunelveli District – 627 105 had been initially started and affiliated under the ambit of the Madurai Kamaraj University, Madurai for conducting **BDS Degree Course** with an annual intake of **50 seats**. Accordingly to the Section 1(3) (a) & 66 of the Tamil Nadu Dr. M.G.R Medical University, Chennai Act 1987 (Act 37 of 1987) the said institution was affiliated to this University in the year 1988.

2. In the reference 2nd & 3rd cited, the University has granted the Provisional Affiliation orders to **Rajas Dental College & Hospital, Kavalkinaru Junction, Tirunelveli District – 627 105** for increase of seats in BDS Degree course **from 50 to 60 seats from the academic year 1992-1993 and 60 to 100 seats from the academic year 1997-1998** respectively. The same was recognised by the Dental Council of India, New Delhi.

3. As resolved by the Governing Council in the reference 5th cited, the University has granted the Conditional Continuance of Provisional Affiliation orders for conducting BDS Degree Course for the academic year 2020-2021 vide reference 6th cited.

4. In the reference 7th cited, the Dental Council of India, New Delhi has informed that the college is hereby directed to not to admit any students in the subject specialities and also to take is final decision for admission to BDS Course and in the speciality of Oral & Maxillofacial Surgery from the academic session 2021-2022 onwards.

5. Subsequently the Rajas Dental College & Hospital, Kavalkinaru Junction, Tirunelveli District has obtained Interim Stay Order dated 09.11.2021 for the Dental Council of India, New Delhi Letter No. DE-15(47)-ACADEMIC-MDS-2021/2761 dated 28.10.2021 and the Institution was included for admission to the BDS Degree Course for the academic year 2021-2022.

6. Due to Covid-19, the University has conducted the Virtual Inspection for the Continuance of Provisional Affiliation for the academic year 2021-2022 through Virtual mode on 22.06.2022 only, and since the academic year 2022-2023 is already in the month of August 2022, based on the Virtual Inspection conducted for the academic year 2021-2022 and the reports submitted by the Inspection Commission, the reports scrutinized for the academic year 2021-2022 is taken for the grant of Continuance of Provisional Affiliation for the academic year 2022-2023 too.

7. Based on the Interim Stay Order dated 09.11.2021, the Institution was included for admission to BDS Degree Course for the academic year 2022-2023 also.

8. As the Building of the said institution are situated in the Non-Plan area hence, **Rajas Dental College & Hospital, Kavalkinaru Jn., Tirunelveli District** has submitted a Notarised affidavit duly signed by the Chairman for the academic years 2021-2022 & 2022-2023 with regards to DTCP approval procedures.

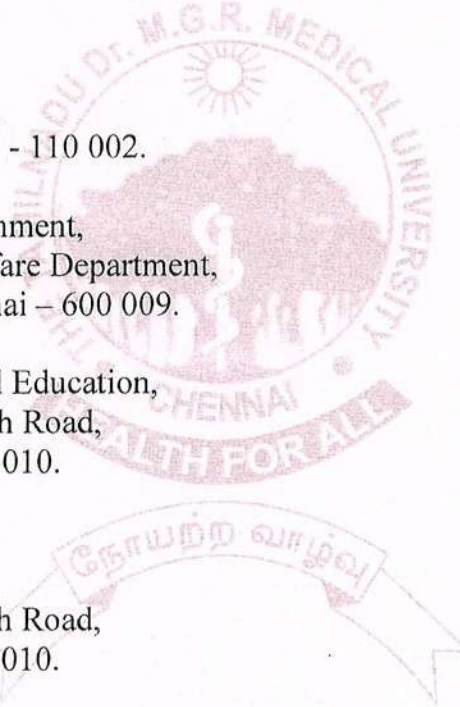
