Cooperation in Education and Research

Objectives:

1. To appoint an Expert Team headed by the Nodal officers of response to coordinate and ease the process of joint development of curriculum and research objectives.
2. To interact and identify common areas of research leading to development of joint multicentre projects which can be conducted and published together.
3. To conduct on-site needs assessment, identify strategically suitable faculty who will take the programme forward as Research Supervisors / Programme mentors.
4. To execute viable financial planning to secure funds, fix course agenda & fees structure and develop time bound plans for project implementation.

The primary contacts for this MoU are Prof. Dr. Johnson Raja James, Vice Principal (Admin) & Director of International Affairs for Rajas Dental College & Hospital (RDC) and Dr. N. Balakrishnan, Principal, S.A. Pharmacy College, Raja nagar, Vadakkangulam- 627116. Both the parties may enter into specific written agreements whenever appropriate to clarify and define the nature, extent and terms of operation for the proposed collaborations, including intellectual property ownership and funding issues.

Both institutions will make available their facilities. The use of facilities and resources by the other party will be at free of cost if there is a joint collaborative activity otherwise the users will pay a nominal fee.

For agreed upon activities, both This MoU will be valid for five (5) years unless terminated by one of the parties. Either institution may withdraw from this MoU provided written notification of the withdrawal is given to the other institution at
