



### BYE - LAWS

1. The Name of the Society the Society will be called as "RAJAS OLD STUDENTS ASSOCIATION"
2. The Address of the Registered office of the society:  
RAJAS DENTAL COLLEGE AND HOSPITAL  
KAVALKINARU JUNCTION,  
RADHAPURAM TALUK,  
TIRUNELVELI DISTRICT - 627105.
3. The date of formation of the society:  
This Association has been formed and it is functioning from the date of 23.12.2017.
4. The Registrar of the District within whose jurisdiction the office of the society is situated  
The registered office of the society is situated under the jurisdiction of "The District Registrar, Tirunelveli.
5. The business hours of the society:  
The Association will be functioning from 10 AM to 4 PM in every working days.
6. The objects of the society:  
Generally the Association will be functioning for bridging all students of Rajas Dental College to utilize the strength of the old students for the betterment of the institution.
7. The activities of the society in furtherance of its objects.
  - 1) The Association will be functioning for the betterment of physically handicapped.
  - 2) For the Welfare of the downtrodden, economically and socially backward.
  - 3) For the improvement of public health
  - 4) For promotion of education, literature, science etc.
8. The name of the person or officer if any authorized to sue or to be sued on behalf of the society:  
The president of the Association is authorized to sue or to be sued on behalf of the Association.

9. The name of the person or officer who is empowered to give directions in regard to the business of the society.  
The secretary of the Association has been empowered to give directions in regard to the business of the Association.
10. Enrolment of members:
- i) Qualification for membership, classification, restrictions and conditions, if any, there for.  
All the old students of Rajas dental college are eligible to become member of the Association.
- ii) The entrance and other fees or subscription if any to be collected from members:  
Those who become members by applying to the committee shall pay an entrance fee of Rs.500/- at the time of enrolment.  
The members shall pay an annual subscription of Rs.1,000/-
- iii) The dates prescribed for payment of the amounts specified in sub - clause (ii) above and levy of penalties or fines if any imposed on defaulting members.  
All the members shall pay the subscription amount before the date of annual general body meeting every year.
- 11) Removal of members, the circumstances under which members could be removed from the roles and the procedure for such removal and appeal, if any, against such removal.  
Those members who fail to pay the subscription amount for three consecutive years shall be removed from the role of membership without giving any notice. Those members who are acting against the bylaws of the association and who are playing any vital role in damaging the name and fame of the association shall be removed from the role of membership by giving show cause notice to such members. The removal of membership shall be the powers vested with the executive committee. Those who are removed from the role of membership for the above said reasons shall make an appeal to the general body of the association through the secretary of the association. The decision of the general body will be final in such removal

12) Rights, obligations and privileges of members:

The members of the association shall be eligible for voting in the subject matters which are placed before the general body meeting and also in the election of office bearers and committee members. ALL the members are eligible to contest in the election of office bearers and committee members. The members those who desire for contesting in the election shall pay the subscription regularly and up to date.

13) The manner in which the association shall transact its business:

The Association shall transact its business and day to day affair with the help of an executive committee duly constituted by the general body through election.

14) The constitution of the committee specified in section 15, the qualification of the members of the committee, their term of office and the procedure for their appointment and reappointment:

- i) The Executive committee of the Association shall consist of one president, two vice presidents, one secretary, one joint secretary, one treasurer and four committee numbers totally 10 members. Those who become members of the executive committee shall be a member of the Association for a continuous period of 2 years and shall not have any arrears of subscription to the Association.
- ii) The elected executive committee shall function for at least three years .After completion of 3 years their term of office shall be ceased automatically. Before completion of 3 years period, the next executive committee shall be elected in the general body meeting for the next triennium.
- iii) If any interim vacancies accrued due to unexpected reasons they shall be filled up by the general body at its next meeting for the remaining period of the existing committee.
- iv) The mode of election shall be decided by the executive committee according to the circumstances.

15) The preparation and filing with the concerned registrar of such records, annual or other statements which are specified in the act and the rules:

The following annual returns shall be prepared and filed with the district registrar by the office bearers within six months from the date of annual general body meeting.

- i) An authenticated copy of such receipts and expenditure account, balance - sheet, and report.
- ii) a statement of the names, addresses and occupations of the persons who, at the expiry of the financial year, were members of the association, and
- iii) A declaration to the effect that the society has been carrying on business or has been in operation during the financial year.
- iv) Copy of resolution passed in the annual general body meeting.

16) The audit of accounts and balance sheet for the financial year with reference of section 16 and the person or persons appointed to do such audit,

- i) The association shall keep proper accounts and at the expiration of each financial year prepare a receipt and expenditure account and a balance sheet and shall cause them to be audited by an auditor appointed by the Association.
- ii) If the receipts and expenditure amount is below Rs.10,000/- (Ten Thousand Only) the accounts shall be audited by two members of the association (not being the members of the committee) appointed for that purpose by the committee having a qualification of SSLC or higher to it.

17) The supply of copies of bye - laws, the receipt and expenditure account and the balance sheet, to the members on application and the fee payable for the same:

The copy of the Byelaws, the receipt and expenditure account and the balance sheet shall be supplied to the members on receiving an application to the secretary with a fee of Rs.1/- (one) for each copy.

18) Imposition of fine if any, for any breach of the provisions of the bye - laws by any member or officer appointed under clause (8) of section 2:

If any of the member or officer of the Association acts against the provisions of the bylaws action shall be taken against them by the committee and suitable penalties or fines shall be levied for the branch of bylaws.

19) The mode of custody, application and investment of the funds of the society and the extent and conditions of such investments:

The funds of the Association shall be invested with Axis Bank Ltd, Nagercoil branch. The Bank account shall be separated jointly by the secretary and the Treasurer.

20) Funds earmarked specifically for the purpose of making provision for a dependant of a deceased or disabled member as laid down in section 25 and the quantum of payments to be made there of:

A Separate fund shall be provided for the purpose of making provision for a dependant of a deceased or disabled member. This fund of the Association and from donations given by the well wishers.

21) Arrangements for transactions of day to day business of the Association the expenditure to be incurred there for the staff to be employed and the condition of service of such employees:

The day to day business of the Association shall be carried over by the Secretary and Treasurer with the help of the staff appointed for that purpose. The appointment of the staff and the payment made to them shall be decided by the executive committee.

22) A) Conduct of annual general body meeting as laid down in section 26 and the procedure there for:

i) The Annual General Body meeting shall be convened every in the month of September. Notice of general body meeting of the Association shall be given to the members at least twenty one days before the day appointed for such meeting.


ii) Notice shall be sent to the members by one or more of the following modes, namely:

- a) by local delivery; or
- b) by post; or
- c) by circulation among the members; or
- d) by publication through press;

iii) The notice shall also be affixed to the notice board of the Association.

B) Conduct of extra - ordinary general body meeting as laid down in section 28 and the procedure there for and the number of members required for making requisition in writing, calling for such a meeting:

The Committee may at any time call an extra - ordinary general meeting for deciding unexpected and urgent matters.

And the committee shall call such a meeting through the secretary within one month from the date of receipt of requisitions from the members in writing.

For convening extra - ordinary general meeting sum 50 members of the Association shall request the secretary in writing with their signatures to take decision against some urgent and important matters.

If the secretary fails to convene such meeting within 30 days by giving 21 days notice from the date of receipt of such requisition the requisitionists themselves shall convene the meeting and decision shall be taken in such meeting.

23) Objectives for which passage of the "Special Resolution" as defined in clause (j) of section 2 is necessary:

A special resolution shall be passed by a majority of not less than three - four of such members of the Association entitled to vote as are present in person at a general body meeting of which a notice of 21 days prior to the date of such meeting specifying the intention to propose the resolution as a special resolution has been duly given.

Resolutions Regarding Amalgamation, Division, Amendment to Byelaws and Memorandum, change of name of the Association shall be passed as 'Special Resolution' with a majority of 3/4<sup>th</sup> of the members present in that general meeting. The copy of the special resolutions shall be filed with the registrar within 3 months from the date of passing.

24) The exhibition of the register of members, the books containing minutes and the books of account at the registered office of the society during business hours for inspection by its members free of charge;

The following books of accounts and the registers with the byelaws of the Association shall be kept opening for inspection by its members with prior permission from the secretary;


